- (i) The appointee shall report to the Principal Government Medical College, Rajouri within 21 days from the date of issue of this order. If he/she fails to join within the stipulated period of time, his/her appointment shall be deemed to have been cancelled ab-initio without serving any notice.

- (iii) The salary of the appointee shall not be drawn and disbursed to him/her unless the satisfactory report in respect of condition (ii) is/are received in his/her favour.
- (iv) The appointee shall be governed by the "New Pension Schemes" as notified vide SRO-400 of 2009 dated 24-12-2009.
- (v) The appointee shall be on probation for a period of two (02) years.
- (vi) The appointment in Divisional Cadre is non-transferable from one Division to another or from one Government Medical College to another.
- (vii) The inter-seniority of the above appointee shall be as per the merit secured by him/her in the selection process as indicated against his/her name in the select list furnished by the ]&K Services Selection Board.
- (viii) The appointment of the selected candidate shall further be subject to outcome of writ petition(s)/litigation if any pending on the subject matter in any court of competent jurisdiction.
