- 2. The appointment under these rules shall not entitle the appointee to any preferential claim for regular appointment.
- 3. The appointee shall be whole timer and shall not engage himself/herself in private practice. In the event of those doctors found resorting to private practice his/her appointment will be terminated without any notice and disciplinary action will be taken against him/her.
- 4. The Junior Resident shall be required to stay in the college/hospital premises if residential accommodation is available or he/she shall have to reside near Associated Hospital.
- 5. The Junior Resident shall be liable to be transferred from the college even during the period of their tenure if his/her services are required in the public interest elsewhere.
- 6. The Junior Resident shall be asked to give an undertaking to the effect that he/she have read the aforesaid terms and condition and he/she shall abide the same before he/she is allowed to join.
- 7. NOC will not be issued if any Junior Resident resigns before a period of 06 months.
- 8. Any appointee doctor intending to leave the job (after 06 months) shall have to provide one month's prior notice duly forwarded by the concerned HOD or else he/she will have to deposit one month's salary with the institution.
- 9. The above candidates shall report to the Principal, Govt. Medical College Rajouri in case of failure of the appointee to join within a period of five days from the date of issuance of this appointment order, he/she shall forego his/her appointment, which shall be deemed to have been cancelled ab-initio without any further notice.
- 10. The appointee under these rules shall have to execute an agreement with the Government on the prescribed form under S.O. 364.
- 11. In case of any interpretation and relaxation regarding the above terms and conditions is concerned, the decision of the undersigned shall be final.
- 12. All original necessary documents shall be produced at the time of joining. Insufficiency in any case shall lead to the cancellation of candidature.
- 13. This order is issued without any prejudice to any writ petitions lying pending before any Hon'ble Court of Law.
